

INFORMATION ABOUT YOUR TICKET

Your summons requires you to appear in person before the Municipal Court of Jackson, Missouri on the date and time indicated on the summons. **If** you wish to plead GUILTY and pay your fine and court costs, it must be paid no later than the day before your scheduled court date. **If** it is your intention to plead NOT GUILTY to the violation, you must appear in court on the date and time indicated on your summons.

Only those violations listed below may be paid prior to court. If your violation is listed and you wish to plead guilty without coming to court, follow these steps:

1. Sign your name to the "Appearance, Plea of Guilty and Waiver" on the back of the ticket.
2. Include a MONEY ORDER or CASHIER'S CHECK made payable to the City of Jackson. NO PERSONAL CHECKS
3. Payments may be made at or mailed to the court office located at **City Hall, 101 Court Street, Jackson.**
4. To pay online please visit www.courts.mo.gov and select the "Payments" button.

NOTICE: YOU MUST APPEAR IN COURT IF YOU WERE INVOLVED IN AN ACCIDENT.

WARNING: A warrant will be issued for your arrest if you fail to appear in court or pay your fine by the scheduled appearance date.
